- 1) Complete an Application for Peddlers, Solicitors and Vendors License.
- 2) A photo ID must be provided.
- 3) A \$10.00 fee is due with completed form and prior to the License being issued.
(fees are not required to be paid by any person who is exempt from the payment of such fee by any provision of state or federal law, girl or boy scouts, veterans in possession of a current valid peddler license, religious organizations which has a valid license, recognized service clubs, persons representing the village schools provided that the sales are sponsored by the school and for the sole benefit of the school.)
- 4) Hours for doing business are from 8:00 a.m. to 8:00 p.m.
Hours for the Village of Ashley Country Christmas are extended until 9:30 p.m.
- 5) Applicants must comply with requirements set forth in Village Ordinance 2013-01 AN ORDINANCE TO PROVIDE FOR THE LICENSING AND REGULATION OF PEDDLERS, SOLICITORS AND OCCASIONAL VENDORS.
